REDISTRICTING CHALLENGE

The lawsuit challenging the 2022 GOP led redistricting of the state legislative districts in Tennessee is moving forward. Hearings are scheduled for the week of April 17, stay tuned to the news for developments. This case has the potential to create more opportunities for Democrats running for the Tennessee House or Senate.

Here are some details of the case:

Davidson County Chancery Court – Wygant V. Lee, Case No. 22-0287-IV, challenges the constitutionality of the House and Senate maps enacted by Republicans in 2022.

The summary judgment order outlines the questions to be resolved at trial for both the Senate and House maps. The numbering of districts is being challenged as being in violation of the Tennessee State Constitution, as well as the splitting

up of counties into multiple districts, which is by ruling of the Tennessee Supreme Court to be held to a minimum, but demonstrably deviates from that standard.

Senate Democratic leadership issued a statement Friday on the trial: “Democracy depends on fair maps that keep our communities whole and reflect who we are as a state. Tennesseans deserve nothing less.”
