ABSENTEE VOTING

Due to the COVID pandemic, many of our members may opt to vote by absentee ballot in August and/or November. Although voters over the age of sixty have always had the right to vote by absentee ballot, up until this past week concern about COVID was not considered sufficient reason for those under sixty to request one. Thanks to a ruling by a Tennessee judge, registered voters concerned about potential exposure to the virus may now apply for an absentee ballot, and the request form has been amended to show that specific reason. This ruling will no doubt be appealed, but as of right now, you may request an absentee ballot for COVID reasons. Stay tuned to local news for any updates.

In Shelby County you may request an absentee ballot application to be mailed to you or you may download one online at www.shelbyvote.com (under the tab for elections, select the upcoming August 6 primary). To have one mailed to you call 901-222-6800 or email absenteevoting@shelbycountytn.gov. All application forms must be submitted to the SCEC by no later than July 30 for the August 6 primary election. Since the August election is a primary, you must indicate which party's primary you wish to vote in (Democratic, we hope!). If you have never voted before, the only way you can vote absentee is if you registered in person. Please contact the election commission if you have any questions at all about your eligibility as a new voter.

The ballots are required to be ready for mailing out to absentee voters by no later than 30 days before the election, or July 7.

STATE AND FEDERAL ELECTIONS

In a summer of pandemic and protest, elections matter more than ever. The

state/federal primary is August 6th (early voting is July 17th thru August 1st); the general election is November 3rd (early voting is October 14th thru October 29th).

The club has endorsed Democratic candidates in races where there are no primary contenders. Our endorsees include club members Jerri Green in District 83, Rep. Dwayne Thompson in District 96, and Julie Byrd Ashworth in Senate District 32. We have also endorsed Lynette Williams in District 95.

In addition, there are several club members or supporters running in primaries in August: Allan Creasy and Gabby Salinas in District 97; Sara Kyle in Senate District 30; GT Dems Steering Committee member Professor Lawrence Pivnick in US House District 8; Congressman Steve Cohen and former SCDP Chair Corey Strong in US House District 9; and James Mackler in the US Senate. We are not endorsing in these races since they are contested primaries.

NOTE: These races cover the districts where the majority of our members live, but there are other races in Shelby County. We support Democrats in all general election races.

All of these candidates need our support. Reach out to get involved through their websites and Facebook pages or contact any club officer if you want to help. Because of the pandemic, traditional voter contact through canvassing may be cut back considerably this year, so advertising and mailers will be more important than ever. These cost money, so please donate to the candidate of your choice to the extent that you are able. We have great candidates running for seats that can be flipped, but the candidates can't do it alone.
